

OSKALOOSA CITY COUNCIL
REGULAR MEETING
January 4, 2021

The Oskaloosa City Council met in regular session on Monday, January 4, 2021 at 6:00 p.m. via electronic meeting in accordance with the State Public Health Emergency Declaration issued by the Governor of the State of Iowa with Mayor Krutzfeldt presiding and the following members answering roll call: Burnett, Caligiuri, Drost, Moore, Ottosson, Walling and Yates. Absent: None.

It was moved by Caligiuri, seconded by Ottosson to approve the consent agenda:

Whereupon the Mayor declared said motion approved.

The Mayor announced there were vacancies on the Airport Commission, Building Code Board of Appeals, Civil Service Commission, Historic Preservation Commission, Municipal Housing Board, and the Stephen Memorial Animal Shelter Board.

The Mayor announced this is the time and place for the public hearing on amending the current budget for fiscal year ending June 30, 2021, and that citizens would now have the opportunity to comment. There were no oral or written comments received. The Mayor declared said hearing closed.

Burnett introduced Resolution No. 21-01-01 entitled "RESOLUTION AMENDING THE CURRENT BUDGET FOR FISCAL YEAR ENDING JUNE 30, 2021" and moved its approval. Drost seconded the motion. The roll was called and the vote was:

Caligiuri introduced "AN ORDINANCE AMENDING CHAPTER 15.12 OF THE MUNICIPAL CODE OF THE CITY OF OSKALOOSA, IOWA." and moved its approval on the third reading. Yates seconded the motion. The roll was called and the vote was:

Whereupon the Mayor declared said ordinance duly adopted. The ordinance was assigned No. 1435.

It was moved by Caligiuri, seconded by Burnett to approve Pay Application No. 13 in the amount of \$10,590.40 to Dave Schmitt Construction Co., Inc. for work completed on the D Street Reconstruction Project. The roll was called and the vote was:
